

Mayor Millsaps called the Special Call Meeting to order at 2:00 P.M. with all Council Members present except Mr. Martin who had a prior meeting.

COUNCIL BUSINESS MEETING – NEW BUSINESS

Mr. Jay Markwalter presented a Special Use Permit SU-10-2 requesting that the council approve his plan to utilize Perry Street between Crogan and Pike Street and Crogan Street between Perry and Clayton Streets for the Rock 'n Rib Fest on October 2, 2010. Mr. Billew informed the council that the plan has been approved by staff. Mr. Crow made a motion to approve Mr. Markwalter's Special Use Permit application and waive the City fee. The motion was seconded by Ms. Beiser. The motion carried unanimously. (See Exhibit File)

Chief Johnson presented the first reading of the proposed Speed Zone Ordinance. Mr. Crow made a motion to approve the first reading of the ordinance. The motion was seconded by Ms. Smith. The motion carried unanimously. (See Exhibit File)

Mr. Matt Benson and Dennis Billew presented the first reading of Zoning Ordinance Amendments to Sections 7.1, 7.2, 7.3, 7.3.1, 7.4, 7.20(T), 7.12, 7.13, 6.2 and Chapter 32 of the City Code of Ordinances. After a brief discussion, the council made the following changes:

Section 6.2 - added the following definition: "(15) AVIATION BUSINESS: Any business engaged in the operation, service, support, maintenance, repair, management or control of aircraft for a fee."

Section 7.12 - under "Special Uses" heading, replaced "Aviation (both general and commercial)" with "Operation of an Aviation Business not otherwise specified herein".

Section 7.13 - under "Special Uses" heading, replaced "(i) Aviation (both general and commercial)" with "(i) Operation of an Aviation Business not otherwise specified herein".

Section 7.20(T) - under "Use Regulations" heading, corrected the spelling of "Disctict" to "District".

Mr. Martin, who had previously returned from a prior meeting, made a motion to approve the first reading of the ordinance amendments. The motion was seconded by Ms. Beiser. The motion carried unanimously. (See Exhibit File)

Mr. Martin then had to excuse himself from the meeting for another prior commitment.

Mr. Benson presented the first reading of the Precious Metal Ordinance. After some discussion from Mr. Benson and Chief Johnson, Ms. Smith made a motion to approve the first reading. The motion was seconded by Ms. Beiser. The motion carried unanimously. (See Exhibit File)

There being no further business, Ms. Smith made a motion to adjourn. The motion was seconded by Ms. Beiser. The motion carried unanimously.
