Mr. Strickland asked for a report from the Planning Department. Mr. Ferguson gave the report and explained that the existing zoning classification is actually BGC and that the applicant would like to sell the property to a buyer to use the property for residential purposes. Mr. Ferguson stated that there are no proposed improvements or changes to the exterior façade but because the property is located within the Downtown Overlay District, the Planning Department recommendation was for approval with the following condition:
